MGA Meeting 12/10/20

- Attendees: Bob Smialek, John Fuzak, Jay Sheldon, Lou Zowine, Brian Dahle, Joe Tisone, Fred Taransky, and Jeff Fields. Excused: Steve Day, Paul Grovum, and Chuck Snyder.
- The Treasurer's report was reviewed; Ending Cash on hand as of 11/30/20 was \$9,791.00. Two events were held in November, the Senior Cup and Shoot-Out. Both events were at capacity. Net income for both events was at \$820.00. We gained 7 new members to the MGA in November plus 1 so far in December for a total of 215 as of 12/9. The rest of the year our projection is to break even on each event excluding raffle proceeds. Raffle proceeds are projected at \$1,000.00, which would leave us at an ending balance of \$6,000.00.
- Status of Events: A recap was given on the 2 events held in November. The Senior Cup was reviewed by Fred Tarnasky and the Shoot-Out by Lou Zowine. Both events were a resounding success! Lou brought up a potential issue with organizing the volunteers for Raffle set up and collection. Due to the current health restrictions the collection of the raffle needs to occur before the start of play, outdoors. Future tournament organizers will need to set this up as early as practical as getting volunteers early in the am will be a challenge. Using the PA system to remind golfers who arrive earlier of the raffle will help.
- Upcoming Events: January Guest Day was cancelled due to the current Global Health issue and the potential risk of having Guests at the club. As a result it was decided to replace this event with a Members only event. It was decided the format for the event will be the 40 Balls Game.

As this game could be confusing to some of our members, it was decided that an instructional sheet and example scorecard would be provided and that John Fuzak, Joe Tisone, and Bob Smialek would help Brian score the event.

- MGA Member Emeritus update: Lou Zowine reviewed that the project is going well. Again, we are planning on recognizing former MGA members who are no longer able to play. Lou stated that he and the team have identified 6 names as eligible. It was voted and approved to allocate \$100.00 to have Award certificates printed. Bob Smialek (President) will put together a letter to accompany the certificates and present to receipiants.
- Recruiting Update: We currently have 215 MGA Members. The club currently has 291 Equity members, 114 Social members.
- New Business: A question was raised to Steve Day regarding the 21 annual members under age 55 and their ability to the join the MGA. It was agreed that if these members wished to join, they had every right to do so, but that this group has restrictions as to when they can play, associated with that type of membership. As such they would be limited to the events they could participate in.
